# AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS RECORDED AT BOOK 12576, PAGE 1461 FOR VALENCIA, A RESIDENTIAL COMMUNITY TO THE CITY OF OKLAHOMA CITY

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS is made this \_\_\_\_\_\_\_\_, day of \_\_\_\_\_\_\_\_\_, 2017, by Valencia Land, L.L.C., an Oklahoma limited liability company ("Declarant").

## Section 1 - Purpose of Amendment.

Declarant is the Declarant of the Additions comprising Valencia which is a platted addition more particularly described within Exhibit "A" hereto. The Declarant intends by the Recording of this Amendment to amend and alter certain provisions of the original Declaration of Covenants, Conditions, and Restrictions recorded at Book 9390, Page 1079-1204 on July 14, 2004 and any amendments and supplemental declarations thereto within the Oklahoma County Clerk's office for Valencia, a residential community to the City of Oklahoma City (Original Declaration). The Declarant executes and adopts this Amendment for the entirety of the real property within Valencia, including those areas added subsequent to the filing of the Original Declaration pursuant to its authority granted and reserved within the Original Declaration.

#### Section 2 - Amendment.

**Design Review Guidelines, Section 4 - Series-Specific Design Standards: Signature Series.** The Signature Series specific design standards within Section 4 of the Design Review Guidelines, set out as Exhibit "F" to the Original Declaration, is hereby deleted and replaced with the following:

Material. The principal exterior of any structure shall be as follows: 1) constructed of up to 65% non-masonry materials may be used without approval from the DRB, and 2) eaves and gables shall be constructed of wood, wood type materials, engineered wood siding products, or cement board. Non-masonry materials include, but are not limited to, frame, wood, vinyl siding or other comparable materials that will blend together with the installed masonry. Any deviation from the above must receive DRB approval prior to installation.

Roofs. All roofs shall be completed using shingles colored Weatherwood, Driftwood, Oakwood, Antique Black or Pewter Gray (gray in color) or equivalent. All roofs shall be



completed using Asphalt Laminated or Composition Equivalent roofing materials. Metal standing seam roof surface is allowed up to 20%. The minimum roof pitch shall be 6/12 front to back and 6 to 12 on sides. Any deviation from the above must receive DRB approval prior to installation. All roofing material shall have a 30-year minimum life.

### Section 3 - Additional Declarations.

All other terms and provisions, including but not limited to covenants, conditions, restrictions, definitions, and exhibits found within the Original Declaration and any amendments and supplemental declarations thereto are hereby incorporated by reference as if each were fully set out within this Amendment. All such terms and provisions, unless expressly and specifically modified by this Amendment, shall remain in effect as first Recorded in the Original Declaration as amended, Declarant hereby reaffirming the same.
